TERMS AND CONDITIONS OF TRADE

1) **INVOICES** : All Invoices are subject to a DUE DATE mentioned on the invoice itself. Customers have to pay for the Invoice before or on the DUE DATE mentioned. The DUE DATE may vary from the Date the Sale is made up to 30 Days.

2) **PAYMENT**: Payment in advance can be requested from KIRAN ELECTRONICS LLC and only after the confirmation of a transaction the Goods (Items Purchased) will be dispatched.
Credit Payments is only an option if the Sales Representative from KIRAN ELECTRONICS LLC approves/advises the customer, in form of writing.

3) **ORDERS**: The Order has to be placed in form of writing from the Customer through an Email, Orders cannot be placed on Phone. On Phone, only inquiries can be made about Availability of a certain item. The Order cannot be considered as final unless a Sales Representative approves of the Order, subjecting to availability and payment agreement.

4) **PRICES**: Prices may vary every day, greatly depending on the availability of the product, on simple demand and supply structure and other similar factors. Before making a purchase, it is the Customer's responsibility to get a Final Quotation. The price list sent out by KIRAN ELECTRONICS LLC will be only valid for the day it is sent on. There is no permanent price list or price for any product, as they may change due to reasons mentioned above, the next day.
It is advised to every customer to ask for the updated Price for the product and place the order the same day, if it needs to be done.

5) **PAYMENT DELAY**: If the payment hasn't been made on the Due Date or KIRAN ELECTRONICS LLC has not received a payment confirmation, it reserves the right to cancel the order. In case of Credit customers, if invoices have exceeded the 30 days' limit, KIRAN ELECTRONICS LLC reserves the right to temporarily suspend or permanently blacklist the account. In case of account suspension, the customer will not be able to place new orders, until the overdue invoices are cleared.

6) **RETURN OF GOODS**:

In Case of Error made by the Customer in terms of Item Name/Quantity, the goods can be returned within 5 UAE working days (Shipping on Customers Expense). When KIRAN ELECTRONICS LLC receives the goods returned, the Invoice will be adjusted accordingly and if necessary the Customer will be paid any amount exceeding the revised Invoice.

In Case of Error made by KIRAN ELECTRONICS in terms of Item Name/Quantity, the goods can be returned within 10 UAE working Days (Shipping on KIRAN ELECTRONICS LLC expense) When KIRAN ELECTRONICS LLC receives the goods returned, the Invoice will be adjusted accordingly and if necessary the Customer will be paid any amount exceeding the revised Invoice.

In Case of Goods returned for no specific reason by the Customer, they need to be shipped on the same day (On Customer's expense). Invoices and Payments will be adjusted accordingly.

7) **Damaged Goods** If Goods have been damaged by the Shipping Company, KIRAN ELECTRONICS LLC does not hold any responsibility. The claim may be settled with the Shipping Company. Check Warranty Section for more details

Please note that KIRAN ELECTRONICS LLC will only replace the Product with another new one of the same model and manufacture, Warranty is not Money Back.

For Warranty Claim the following terms apply:

- i. The company is notified in writing within 7 days of the Customer first discovering any such defects.
- ii. The Goods have been used in an appropriate manner and/or as prescribed in the operating instructions (if any).
- iii. The defective Goods are returned, along with a copy of the purchase invoice to the Company, at the Customers expense.
- iv. Examination by the Company of such Goods proves that such defects exist and have not been caused by misuse, neglect, accident,

improper storage installation or handling or by repair or alteration not affected by the Company.
v. The Goods not having been modified or repaired otherwise than by the Company or otherwise interfered with and

vi. The Customer shall pay to the Company the costs (as certified by the Company) for any examination of such goods that proves that the defects were caused by misuse, neglect, accident, improper storage installation or handling or by repair or alteration by unauthorised service centers, as a result of which the Company denies liability.
